# 1.0 Introduction

Foods Wise Network Sdn Bhd is committed to the highest standards of business and ethical behaviour including compliance with all applicable laws and regulations, as well as company policies, practices and procedures. Foods Wise Network Sdn Bhd respects internationally recognised Human Rights as established in the Universal Declaration on Human Rights and the International Labour Organisation's Core Conventions.

In line with the UN Guiding Principles on Business and Human Rights, Foods Wise Network Sdn Bhd recognises the corporate responsibility to respect these principles and commit to 'know and show' this through on-going human rights due diligence. Furthermore, our efforts include ongoing robust engagement with our business and major supply chain partners to mitigate potential human rights impacts beyond our direct control.

Our support of internationally recognised Human Rights is consistent with our dedication to enriching our workplace, partnering with our supply chain, preserving the environment and supporting the communities where we operate.

## 2.0 Policy Objectives

The objective of Foods Wise Network Sdn Bhd documented policies is to provide an overview of expectations for employees and business partners.

In addition, the Human Rights policy exists to:

2.1 Inform employees, business partners and customers of Foods Wise Network Sdn Bhd commitment to human rights.

2.2 Establish Foods Wise Network Sdn Bhd commitment to 'know and show' its respect for human rights through on-going human rights due diligence.

2.3 Maintain Foods Wise Network Sdn Bhd high ethical standards.

2.4 Contribute to the realisation of human rights globally.

## 3.0 Policy Scope

Foods Wise Network Sdn Bhd's Human Rights Policy applies to all Foods Wise Network Sdn Bhd employees worldwide, anyone doing business for or with Foods Wise Network Sdn Bhd and others acting on Foods Wise Network Sdn Bhd's behalf. This applies to all locations where Foods Wise Network Sdn Bhd conducts business and to all company-sponsored events.



# 4.0 Definitions

Human rights are basic rights inherent to all human beings, regardless of nationality, place of residence, sex, sexual orientation, national or ethnic origin, colour, religion, language, or any other status.

## 5.0 Guidelines

Foods Wise Network Sdn Bhd conducts its business in a manner that respects the rights and dignity of all people, complying with all applicable laws and regulations. Our policies reflect our commitment to respecting the protection of internationally recognised Human Rights.

5.1 All employment with Foods Wise Network Sdn Bhd is voluntary. We do not use child or forced labour in any of our operations or facilities. We do not tolerate any form of unacceptable treatment of workers, including but not limited to the exploitation of children, physical punishment or abuse, or involuntary servitude. We fully respect all applicable laws establishing a minimum age for employment, in order to support the effective abolition of child labour worldwide.

5.2 Foods Wise Network Sdn Bhd abides by all laws and regulations regarding pay practices and the classification of employment according to job level and status.

5.4 Diversity is embraced at Foods Wise Network Sdn Bhd. We recognize that a diverse mix of backgrounds, skills and experiences drives new ideas, products, and services and provides us with a sustained competitive advantage.

5.5 We believe everyone should be treated with respect regardless of their background. We are committed to the elimination of discrimination based on gender, race, class, economic status, ethnic background, sexual orientation, age, political beliefs, veteran status, marital status or any other protected class.

5.7 We respects all human rights.

5.8 We commits to conducting on-going human rights due diligence to assess and mitigate potential human rights infringements.

5.9 Foods Wise Network Sdn Bhd expects those with whom it does business to respect all human rights.

## 6.0 Responsibility

The Human Rights policy is owned and maintained by Foods Wise Network Sdn Bhd Human Resources function. Human Resources is responsible for the creation, administration, updating and communication of the policy.



# 7.0 Compliance

Employees and suppliers are expected to comply with this and all applicable Foods Wise Network Sdn Bhd policies. Violation of this policy or the refusal to cooperate will result in disciplinary action, up to and including termination and referral to the appropriate authorities, where we have sound reason to believe that our partner organization infringe Human Rights we reserve the right to cease those relationships as warranted.

Specific to this policy, employees and suppliers are expected to:

7.1 Never infringe on human rights.

7.2 Be alert to any evidence of human rights infringements in our direct operations or in the operations of our business partners and report any situation in which a human rights infringement is suspected.
